- Pays a Preferred Member Fee
- Privileges:
  - 10-day Advance Tee Times
  - Immediate Family Privileges
  - No Extended Family Privileges
  - Two (2) Golf Starting Times Per Month or Twelve (12) Rounds of Golf During the Six-Month Period Commencing November 1 and ending on April 30 (“Season”)
  - No Limit on Golf Times during the Six-Month Period Commencing May 1 and ending on October 31 (“Off-Season”)
  - During Season, Practice Facilities Restricted to Immediately Before or After a Round of Golf or Scheduled Golf Lesson
  - During the Off-Season, Unlimited Use of the Practice Facilities
  - No Participation in Men’s or Women’s Golf Association Play
  - May Participate in Designated Club-Sponsored Golf and Social Events
  - Use of the Lockers and Golf Bag Storage Facility on a Space Available Basis
  - Membership Charging Account
